# 1 Introduction

- 1.1 Woodbrook Vale School fully recognises the contribution it can make to protect children and support students in school. The aim of the policy is to safeguard and promote our students' welfare, safety and health by fostering an honest, open, caring and supportive climate. The students' welfare is of paramount importance.
- 1.2 This policy is consistent with:
  - the legal duty to safeguard and promote the welfare of children, as described in section 157 of the Education Act 2002 and the statutory guidance "Keeping children safe in education Statutory guidance for schools and colleges", September 2019 and "Working Together to Safeguard Children", 2018;
  - the Leicestershire and Rutland Safeguarding Children Partnership Multi Agency Safeguarding Arrangements.
- 1.3 There are four main elements to our Safeguarding Policy:
  - **Prevention:** e.g. positive school atmosphere, teaching and pastoral support to students, safer recruitment procedures;
  - **Protection:** by following agreed procedures, ensuring staff are trained and supported to respond appropriately and sensitively to Child Protection concerns;
  - Support: to students and school staff and to children who may have been abused;
  - Working with parents: to ensure appropriate communications and actions are undertaken.
- 1.4 This policy applies to all staff, volunteers' governors and visitors to the school. We recognise that child protection is the responsibility of all adults in school. We will ensure that all parents and other working partners are aware of our Safeguarding Policy by mentioning it in our school prospectus, displaying appropriate information in our reception and on the school website and by raising awareness at meetings with parents as appropriate.

# 1.5 Extended school activities

Where the Governing Board provides services or activities directly under the supervision or management of school staff, the school's arrangements for child protection will apply. Where services or activities are provided separately by another body, the Governing Board will seek assurance in writing that the body concerned has appropriate policies and procedures in place to safeguard and protect children and there are arrangements to liaise with the school on these matters where appropriate.

# 2 Safeguarding Commitment

2.1 The school adopts an open and accepting attitude towards children as part of its responsibility for pastoral care. Staff encourage children and parents to feel free to talk about any concerns and to see school as a safe place when there are difficulties. Children's worries and fears will be taken seriously, and children are encouraged to seek help from members of staff.

- 2.2 Our school will therefore:
  - Establish and maintain an ethos where children feel secure and are encouraged to talk, and are listened to;
  - Ensure that children know that there are adults in the school whom they can approach if they are worried or are in difficulty;
  - Include in the curriculum activities and opportunities for Personal Development/Citizenship which equip children with the skills they need to stay safe from abuse (including online, and other contexts that children are in), and to know to whom they can turn for help;
  - Ensure every effort is made to establish effective working relationships with parents and colleagues from other agencies;
  - Operate safer recruitment procedures and make sure that all appropriate checks are carried out and recorded on the Single central record on new staff and volunteers who will work with children, including identity, right to work, enhanced DBS criminal record and barred list (and overseas where needed), references and prohibition from teaching or managing in schools (s128) etc.
- 2.3 Safeguarding in the Curriculum

Children are taught about safeguarding in school. The following areas are among those addressed in Personal Development and in the wider curriculum:

Bullying, including Cyber-bullying

Domestic abuse/ Healthy Relationships / Consent

Drugs, alcohol and substance abuse (including awareness of County Lines and the criminal exploitation of children where appropriate)

Online safety

The danger of meeting strangers

Fire and water safety

Road safety

Sex and Relationships Education

(so called) Honour Based Violence issues (HBV) e.g. forced marriage, Female Genital Mutilation (FGM) (see Appendix 6),

Sexual exploitation of children (CSE) including online

Preventing Extremism and Radicalisation (see Appendices 4 and 5)

# 3 Roles and Responsibilities

# 3.1 General

All adults working with or on behalf of children have a responsibility to safeguard and promote their welfare. This includes a responsibility to be alert to possible abuse and to record and report concerns to staff identified with child protection responsibilities within the school.

The names of the Designated Safeguarding Leads and Deputy Designated Safeguarding Leads for the current year are listed at the start of this document.

#### 3.2 Governing Board

In accordance with the Statutory Guidance "Keeping children safe in education" (September 2018), the Governing Board will ensure that:

- The school has its own child protection/safeguarding policy, procedures and training in place which are effective and comply with the law at all times. The policy is made available publicly.
- The school operates safer recruitment practices, including appropriate use of references and checks on new staff and volunteers. Furthermore, the Headteacher, a nominated Governor and other staff involved in the recruitment process have undertaken Safer Recruitment Training.
- There are procedures for dealing with allegations of abuse against members of staff and volunteers (see Appendix 2).
- There is a senior member of the school's leadership team who is designated to take lead responsibility for dealing with child protection (the "Designated Safeguarding Lead") and that there is always cover for this role, with appropriate arrangements for before/after school and out of term activities.
- The Designated Safeguarding Lead undertakes effective Local Authority training (in addition to basic child protection training) and this is refreshed every two years. In addition to this formal training, their knowledge and skills are updated at regular intervals (at least annually) via safeguarding briefings etc.
- The Headteacher, and all other staff and volunteers who work with children, undertake appropriate training which is regularly updated (at least every three years in compliance with the Safeguarding Children Partnership protocol); and that new staff and volunteers who work with children are made aware of the school's arrangements for child protection and their responsibilities (including this policy, Part 1 of Keeping Children Safe in Education, the Student Behaviour Policy and how to respond if children go missing). The Local Authority Induction leaflets, "Safeguarding in Education Induction – Child Protection Information, Safer Working Practice" will be used as part of this induction and Annex A from "Keeping children safe in education" September 2019 is provided to all staff working directly with children.
- Any deficiencies or weaknesses brought to the attention of the Governing Board will be rectified without delay.
- Chair of Governors (or, in the absence of a Chair, the Vice Chair) deals with any allegations of abuse made against the Headteacher, in liaison with the Local Authority Allegations Manager (LADO).
- Effective policies and procedures are in place and updated annually including a behaviour "code of conduct" for staff and volunteers – "Guidance for Safer Working Practice for those who work with children in education settings" May 2019. Information is provided to the Local Authority (on behalf of the Safeguarding Children Partnership) through the Safeguarding Annual Return.
- There is an individual member of the Governing Board who will champion issues to do with safeguarding children and child protection within the school, liaise with the Designated Safeguarding Lead, and provide information and reports to the Governing Board.

The school contributes to inter-agency working in line with statutory guidance "Working Together to Safeguard Children" 2015 including providing a co-ordinated offer of Early Help for children who require this. This Early Help may be offered directly through school provision or via referral to an external support agency Safeguarding arrangements take into account the procedures and practice of the local authority and the Leicestershire and Rutland Safeguarding Children Partnership.

#### 3.3 Headteacher

The Headteacher of the school will ensure that:

- The policies and procedures adopted by the Governing Board are effectively implemented and followed by all staff.
- Sufficient resources and time are allocated to enable the Designated Safeguarding Lead and other staff to discharge their responsibilities, including taking part in strategy discussions and other inter-agency meetings, and contributing to the assessment of children.
- Allegations of abuse or concerns that a member of staff or adult working at school may pose a risk of harm to a child or young person are notified to the Local Authority Designated Officer.
- All staff and volunteers feel able to raise concerns about poor or unsafe practice in regard to children, and such concerns are addressed sensitively and effectively in a timely manner. The NSPCC whistle blowing helpline number is also available (0800 028 0285)
- All staff are made aware that they have an individual responsibility to pass on safeguarding concerns and that if all else fails to report these directly to Children's Social Care (Children's Services) or the Police.

# 3.4 **Designated Safeguarding Lead**

The responsibilities of the Designated Safeguarding Lead are found in Annex B of "Keeping children safe in education" and include:

- Provision of information to the Partnership on Safeguarding and Child Protection on Safeguarding and children
- Liaison with the Governing Board and the Local Authority on any deficiencies brought to the attention of the Governing Board and how these should be rectified without delay.
- Management and referral of cases of suspected abuse to Specialist Services First Response Children's Duty (and/or Police where a crime may have been committed).
- Act as a source of support, advice and expertise within the school.
- To attend and contribute to child protection conferences when required.
- Be alert to the specific needs of children in need, those with special educational needs and disability and young carers.
- Ensure each member of staff has access to and understands the school's safeguarding / child protection policy especially new or part-time staff who may work with different educational establishments.

- Ensure all staff have induction training covering child protection, the student behaviour policy, children who go missing and and staff behaviour. Staff will be trained to recognise record and report any concerns immediately they arise and will be provided with Part 1 of "Keeping children safe in education" and Annexe A to those working directly with children.
- Keep detailed signed and dated, accurate and secure written records of concerns and referrals.
- Obtain access to resources and effective training for all staff and attend refresher training courses every two years. Keep up to date with new developments in safeguarding by accessing briefings and journals at least annually.
- Where children leave the school, ensure their child protection file is handed to the Designated Safeguarding Lead and signed for in the new school/college as soon as possible – this will be in advance of the student arriving where specific ongoing support is required.
- Maintain and monitor child protection records, including monitoring and acting upon individual concerns, patterns of concerns (e.g. children who repeatedly go missing) or complaints, in accordance with the section on "Records and Monitoring and Transfer" below.

# 4 Records, Monitoring and Transfer

- 4.1 Well-kept records are essential to good child protection practice. All staff are clear about the need to record and report concerns about a child or children within the school. Records of concerns are written down, signed and dated and passed immediately to a Designated Safeguarding Lead. The Designated Safeguarding Lead is responsible for such records on CPOMS and for deciding at what point these records should be passed over to other agencies.
- 4.2 Records relating to actual or alleged abuse or neglect are stored apart from normal student or staff records. Normal records sometimes have markers to show that there is sensitive material stored elsewhere. This is to protect individuals from accidental access to sensitive material by those who do not need to know.
- 4.3 Child protection records are stored securely, with access confined to specific staff, e.g. Designated Safeguarding Leads and the Headteacher.
- 4.4 Child protection records are reviewed regularly to check whether any action or updating is needed. This includes monitoring patterns of complaints or concerns about any individuals and ensuring these are acted upon. A case file chronology, summarizing case activity, helps to enable effective monitoring. Any actions taken are clearly indicated.
- 4.5 When children transfer school their safeguarding records are also transferred. Safeguarding records will be transferred separately from other records and best practice is to pass these directly to a Designated Safeguarding Lead in the receiving school or Sixth Form / Further Education College, with any necessary discussion or explanation and to obtain a signed and dated record of the transfer. Where a child needs specific ongoing support, relevant information will be transferred prior to the child arriving at their new school. In the event of a child moving out of area and a physical handover not being possible then the most secure method should be found to send the confidential records to a named Designated Safeguarding Lead and a photocopy kept. Files requested by other agencies e.g. Police should be copied.

# 5 Support to students and school staff

#### 5.1 **Support to students**

Our school recognises that children who are abused or who witness violence may find it difficult to develop a sense of self-worth and view the world in a positive way. For such children school may be one of the few stable, secure and predictable components of their lives. Other children may be vulnerable because, for instance, they have a disability, are in care, a care-leaver or previously looked after, or are experiencing some form of neglect. Our school seeks to remove any barriers that may exist in being able to recognise abuse or neglect in students with Special Educational Needs or Disability. We will seek to provide such children with the necessary support and to build their selfesteem and confidence. The context in which safeguarding incidents and/or behaviours occur, whether in school or outside (including online), will be considered by staff, particularly the DSL and Deputy DSL's. Any associated threats or risks will be included in assessments and relevant information included in referrals to Children's Social Care (this is known as contextual safeguarding). General indicators of abuse and neglect (from Part 1of the statutory guidance) are also included in Appendix 7 of this policy and further information about specific forms of abuse are contained within Appendix A of the statutory guidance, "Keeping Children Safe in Education 2019".

#### 5.2 Internet Filtering

Our school uses an online filtering appliance which blocks access, on all devices, to inappropriate websites. These include adult content, race hate, gaming and gambling. Changes to the filtering policy can only be made with the approval of the ICT systems manager and the Senior Leadership Team link. All changes are recorded centrally. Our schools' internet filtering complies with PREVENT legislation, highlighting any breaches or early warning signs of extremism or radicalisation.

#### 5.3 Peer on Peer Abuse

This school recognises that children sometimes display abusive behaviour themselves and that such incidents or allegations must be referred on for appropriate support and intervention. Such abuse will not be tolerated or passed off as "banter" or "part of growing up". This abuse could for example include sexual violence and sexual harassment, upskirting, initiation/hazing type violence, all forms of bullying, aggravated sexting and physical violence experienced by both boys and girls. There are separate school and local authority/or Safeguarding Children Partnership guidelines and/or policies to address these concerns including the student Behaviour Policy, Anti-bullying Policy, E-safety Policy and "Guidance for schools working with children who display harmful sexual behaviour" (Leicestershire LA Guidance). Where specific risks are identified, a risk assessment will be undertaken in order to ensure the safety of all staff and students and to offer appropriate support.

#### 5.4 Sexting

School will always respond if informed that children have been involved in 'sexting' (youth produced sexual imagery). The UK Council for Child Internet Safety (UKCCIS) guidance, "Sexting in schools and colleges: responding to incidents and safeguarding young people" will be used to guide the school's response on a case by case basis. The key points being:

- · Inform the Headteacher/DSL as soon as possible
- Support the victim as appropriate and in accordance with their best interests
- Inform all parents of involved children unless by doing so you put a child at risk

- Images will not be viewed by school staff
- If school is to deal with the matter, involve parents in ensuring the images are deleted
- If there is evidence of exploitation or the targeting of a vulnerable student, inform the police

# 5.5 **Sexual violence and sexual harassment**

Sexual violence refers to sexual offences as described under the Sexual Offences Act 2003 including rape and sexual assault. Sexual harassment is 'unwanted conduct of a sexual nature' that occur online and offline and may include sexual name-calling, taunting or "jokes" and physical behaviour, for example, deliberately brushing against someone or interfering with clothes. Upskirting is now a criminal offence and typically involves taking a pictures under a person's clothing without them knowing in order to obtain sexual gratification or to cause humiliation, distress or alarm. Evidence shows that girls, children with SEND and LGBT children are more likely to be the victims of sexual violence and harassment and boys are more likely to be the perpetrators. However, sexual violence and sexual harassment can occur between children of any gender.

# Curriculum

Planned Personal Development and SRE will include "healthy and respectful behaviours. This will be appropriate to students' age and stage of development. It will also be underpinned by the schools' behaviour policy and pastoral support system.

Responding to an incident

- School will follow the DfE guidance, 'Sexual violence and sexual harassment between children in schools and colleges, May 2018.
- We will liaise with the police, social care and parents as appropriate.
- We will offer support to both the victim(s) and perpetrator(s). Parents will be included in discussions about the format that this support will take.

# 5.6 Children Missing (including absence from school)

Our school recognises the entitlement that all children have to education and will work closely with the local authority to share information about students who may be missing out on full time education or who go missing from education. The local authority will also be informed where children are to be removed from the school register a) to be educated outside the school system; b) for medical reasons; c) because they have ceased to attend; d) because they are in custody; d) because they have been permanently excluded. We also recognise that children who go missing is a sign that they have been targeted by CSE perpetrators and / or drug related criminals (County Lines). Children may also be groomed into participating in other forms of criminal exploitation including serious violence and violent crime. Children who attend an alternative education are more likely to be vulnerable to these forms of exploitation.

# 5.7 Child sexual exploitation

Is a form of sexual abuse where children are sexually exploited for money, power or status. It can involve violent, humiliating and degrading sexual assaults. In some cases, young people are persuaded or forced into exchanging sexual activity for money, drugs, gifts, affection or status. A significant number of children who are victims of sexual exploitation go missing from home, care and education at some point or are targeted by criminals involved in the illegal supply of drugs (County Lines) and serious violent crimes. Staff training includes raising awareness of this issue and any concerns

are passed to the Designated Safeguarding Lead who will make a risk assessment and refer to Local Authority First Response Children's Duty if appropriate.

#### 5.8 So-called 'honour-based' violence

HBV encompasses crimes which have been committed to protect or defend the socalled "honour" of the family and/or the community, including Female Genital Mutilation (FGM) (see appendix 6), forced marriage, and practices such as breast ironing. All forms of so-called HBV are abuse (regardless of the motivation) and concerns will be passed to the Designated Safeguarding Lead for onward referral as required.

#### 5.9 **Private fostering arrangements**

Where a child under 16 (or 18 with a disability) is living with someone who is not their family or close relative for 28 days or more, staff inform the designated Safeguarding Lead so that a referral to Children's Social Care for a safety check, can be made. (A close relative includes stepparent, grandparents, uncle, auntie or sibling).

5.10 Complaints or concerns raised by parents or students will be taken seriously and followed up in accordance with the school's complaints process.

#### 5.11 Support for Staff

As part of their duty to safeguard and promote the welfare of children and young people staff may hear information, either from the child/young person as part of a disclosure or from another adult that will be upsetting. Where a member of staff is distressed as a result of dealing with a child protection concern, he/she should in the first instance speak to the Designated Safeguarding Lead about the support they require. The Designated Safeguarding Lead should seek to arrange the necessary support.

#### 6 Working with parents/carers

The school will:

- Ensure that parents/carers understand the responsibility placed on the school and staff for child protection by setting out its obligations in the school prospectus.
- Undertake appropriate discussion with parents/carers prior to involvement of Children & Family Services Children's Social Care or another agency, unless to do so would place the child at risk of harm or compromise an investigation.

# 7 Other Relevant Policies

- 7.1 The Governing Board's statutory responsibility for safeguarding the welfare of children goes beyond simply child protection. The duty is to ensure that safeguarding permeates all activity and functions. This policy therefore complements and supports a range of other policies, for instance:
  - Bullying (including cyber-bullying)
  - Attendance and Punctuality
  - Behaviour and Rewards
  - Equality Act Statement
  - Health and Safety
  - Relationships and Sex Education
  - Special Educational Needs and Disability
  - Staff Disciplinary
  - Work Experience

The above list is not exhaustive but when undertaking development or planning of any kind the school will consider the implications for safeguarding and promoting the welfare of children.

# 8 Recruitment and Selection of Staff

- 8.1 The school's safer recruitment processes follow the Statutory Guidance: *"Keeping children safe in education"* September 2019 Part 3: Safer recruitment.
- 8.2 The school will provide all the relevant information in references for a member of staff about whom there have been concerns about child protection / inappropriate conduct. Cases in which an allegation has been proven to be unsubstantiated, unfounded, false or malicious will not be included in employer references. A history of repeated concerns or allegations which have all been found to be unsubstantiated, malicious etc. will also not be included in a reference.
- 8.3 The school has an open safeguarding ethos regularly addressing safeguarding responsibilities during staff meetings and fostering an ongoing culture of vigilance. All new staff and volunteers receive a safeguarding induction and are briefed on the code of conduct for adults working with children. The Leicestershire County Council induction leaflet is given to all staff and is the basis for the safeguarding induction.
- 8.4 In line with statutory requirements, every recruitment process for school staff will have at least one member (teacher/manager or governor) who has undertaken safer recruitment training.

#### **APPENDIX 1**

#### PROCEDURE TO FOLLOW IN CASES OF POSSIBLE, ALLEGED OR SUSPECTED ABUSE, OR SERIOUS CAUSE FOR CONCERN ABOUT A CHILD

#### A. General

- The Leicestershire and Rutland Safeguarding Children partnership procedures contain the inter-agency processes, protocols and expectations for safeguarding children. (Available on website <u>http://lrsb.org.uk/</u>). The Designated Safeguarding Lead is expected to be familiar with these, particularly the indicators of abuse and neglect and the referral processes.
- 2) It is important that all parties act swiftly and avoid delays.
- 3) Any person may seek advice and guidance from First Response Children's Duty Professionals Consultation Line, particularly if there is doubt about how to proceed. Any adult, whatever their role, can take action in his/her own right to ensure that an allegation or concern is investigated and can report to the investigating agencies.
- 4) A record, dated (including the day and time) and signed, must be made as to what has been alleged, noticed and reported, and kept securely and confidentially.
- 5) In many cases of concern there will be an expectation that there have already been positive steps taken to work with parents and relevant parties to help alleviate the concerns and effect an improvement for the child. This is appropriate where it is thought a child may be in need in some way and require assessment to see whether additional support and services are required. An example might be where it is suspected a child may be the subject of neglect. In most cases the parents' knowledge and consent to the referral are expected, unless there is reason for this not being in the child's interest. However, there will be circumstances when informing the parent/carer of a referral that might put the child at-risk, and in individual cases advice from Children's Social Care will need to be taken.

#### B. Individual Staff/Volunteers/Other Adults – main procedural steps

- When a child makes a disclosure, or when concerns are received from other sources, <u>do</u> <u>not</u> investigate, ask leading questions, examine children, or promise confidentiality. Children making disclosures should be reassured and if possible, at this stage should be informed what action will be taken next.
- 2) As soon as possible make a dated (including the day), timed and signed record of what has been disclosed or noticed, said or done and report to the Designated Safeguarding Lead in the school.
- 3) If the concern involves the conduct of a member of staff or volunteer, a visitor, a governor, a trainee or another young person or child, the Headteacher must be informed.
- 4) If the allegation is about the Headteacher, the information should normally be passed to the Chair of Governors or the Local Authority Allegations Manager (LADO).

5) If this has not already been done, inform the child (or other party who has raised the concern) what action you have taken.

# C. Designated Safeguarding Lead – main procedural steps

- 1) Begin an individual case file for each child involved which will hold a record of communications and actions to be stored securely (see Section on Records, Monitoring and Transfer). Include a chronology of case activity.
- 2) Where initial enquiries do not justify a referral to the investigating agencies inform the initiating adult and monitor the situation. If in doubt, seek advice from First Response Professionals Consultation line.
- 3) Share information confidentially with those who need to know.
- 4) Where there is a child protection concern requiring immediate, same day, intervention from Children's Social Care (Priority 1), the First Response Children's Duty should be contacted by phone. Written confirmation should be made within 24 hours on the LSCB Multi-Agency Referral Form to Children's Social Care. All other referrals should be made using the online form (http://lrsb.org.uk/childreport).
- 5) If the concern is about children using sexually abusive behaviour, refer to the separate guidance, "Guidance for schools working with children who display harmful sexual behaviour" (Leicestershire LA guidance).
- 6) If it appears that urgent medical attention is required, arrange for the child to be taken to hospital (normally this means calling an ambulance) accompanied by a member of staff who must inform medical staff that non-accidental injury is suspected. Parents must be informed that the child has been taken to hospital.
- 7) Exceptional circumstances: If it is feared that the child might be at immediate risk on leaving school, take advice from First Response Professionals Consultation line (for instance about difficulties if the school day has ended, or on whether to contact the police). Remain with the child until the Social Worker takes responsibility. If in these circumstances a parent arrives to collect the child, the member of staff has no right to withhold the child, unless there are current legal restrictions in force (e.g. a restraining order). If there are clear signs of physical risk or threat, First Response Children's Duty should be updated, and the Police should be contacted immediately.

# PROCEDURE FOR DEALING WITH ALLEGATIONS AGAINST STAFF (INCLUDING HEADTEACHERS) AND VOLUNTEERS

These procedures should be followed in all cases in which there is an allegation or suspicion that a person working with children has:

- behaved in a way that has harmed a child, or may have harmed a child;
- possibly committed a criminal offence against or related to a child; or
- behaved towards a child or children in a way that indicates he or she would pose a risk of harm to children.

Relevant documents:

- DfE "Keeping children safe in education: Statutory guidance for schools and colleges" (September 2019 Part 4: Allegations of abuse made against teachers and other staff).
- 1) Individual Staff/Volunteers/Other Adults who receive the allegation:
  - i. Write a dated and timed note of what has been disclosed or noticed, said or done.
  - ii. Report immediately to the Headteacher.
  - iii. Pass on the written record.
  - iv. If the allegation concerns the conduct of the Headteacher, report immediately to the Chair of Governors. Pass on the written record. (If there is difficulty reporting to the Chair of Governors, contact the Allegations Manager, (LADO) Safeguarding and Improvement Unit as soon as possible).

# 2) Headteacher (or Chair of Governors)

- i. If there is no written record, write a dated and timed note of what has been disclosed or noticed, said or done.
- ii. Before taking further action notify and seek advice from the Allegations Manager, (LADO), Safeguarding and Improvement Unit on the same day.
- iii. You may be asked to clarify details or the circumstances of the allegation, but this must not amount to an investigation.
- iv. Report to First Response Children's Duty if the Allegations Manager (LADO) so advises or if circumstances require a referral concerning a child.
- v. Ongoing involvement in cases:
  - Liaison with the Allegations Manager (LADO).
  - Co-operation with the investigating agency's enquiries as appropriate.
  - Consideration of employment issues and possible disciplinary action where the investigating agencies take no further action.
  - Possible referral to the DBS or The Teaching Regulation Agency, depending on the outcome.

# APPENDIX 3

# CHILD PROTECTION

Woodbrook Vale School fully recognises its responsibilities for child protection.

Our policy applies to all staff, governors and volunteers working in the school. There are five main elements to our policy:

- Ensuring we practice safe recruitment in checking the suitability of staff and volunteers to work with children.
- Raising awareness of child protection issues and equipping children with the skills needed to keep them safe.
- Developing and then implementing procedures for identifying and reporting cases, or suspected cases, of abuse.
- Supporting students who have been abused in accordance with his/her agreed child protection plan.
- Establishing a safe environment in which children can learn and develop.

We recognise that because of the day to day contact with children, school staff are well placed to observe the outward signs of abuse. The school will therefore:

- Establish and maintain an environment where children feel secure, are encouraged to talk, and are listened to.
- Ensure children know that there are adults in the school whom they can approach if they are worried.
- Include opportunities in the Personal Development curriculum for children to develop the skills they need to recognise and stay safe from abuse.

We will follow the procedures set out by the Leicestershire and Rutland Safeguarding Children Partnership and take account of guidance issued by the DfE:

- Ensure we have a Designated Safeguarding Lead who has received appropriate training and support for this role. Sarah Anderson (Deputy Headteacher – Pastoral) is the Designated Safeguarding Lead. Rachael Fraser (Headteacher), Paul Hynes (Deputy Headteacher), Peter Hayes (Assistant Headteacher), Rebecca Moors (Assistant Headteacher), Jackie Whelband (Student Support Mentor) and Sarah Smith (SEND administrator) are also trained as safeguarding leads. Rachael Fraser is trained in Staff Allegations.
- Any member of staff who receives a disclosure of abuse, or suspects that abuse may have occurred must report it as soon as possible to one of the above.
- Ensure we have a nominated governor responsible for child protection. This is currently Jo Kavanagh.
- Ensure every member of staff, volunteer and governor knows the name of the Designated Safeguarding Lead and their role.
- Ensure all staff and volunteers understand their responsibilities in being alert to the signs of abuse and responsibility for referring any concerns to the Designated Safeguarding Lead.
- Ensure that parents understand the responsibility placed on the school and staff for child protection; this will be included in the Home-School Agreement.
- Notify Children's Social Care: Central Duty Team if there is an unexplained absence of more than two days of a student who is on the child protection register.

- Develop effective links with relevant agencies and co-operate as required with their enquiries regarding child protection matters including attendance at case conferences.
- Keep written records of concerns about children, even where there is no need to refer the matter immediately.
- Ensure all records are kept securely; separate from the main student file, and in locked locations.
- Develop and then follow procedures where an allegation is made against a member of staff or volunteer.
- Ensure safe recruitment practices are always followed.

We recognise that children who are abused or witness violence may find it difficult to develop a sense of self worth. They may feel helplessness, humiliation and some sense of blame. The school may be the only stable, secure and predictable element in the lives of children at risk. When at school their behaviour may be challenging and defiant or they may be withdrawn. The school will endeavour to support the student through:

- The content of the curriculum.
- The school ethos, which promotes a positive, supportive and secure environment and gives students a sense of being valued.
- The school behaviour policy, which is aimed at supporting vulnerable students in the school. The school will ensure that the student knows that some behaviour is unacceptable, but they are valued and not to be blamed for any abuse which has occurred.
- Liaison with other agencies that support the student such as social services, Child and Adult Mental Health Service, Education Welfare Service and Educational Psychology Service.
- Ensuring that, where a student on the child protection register leaves, their information is transferred to the new school immediately and that the child's social worker is informed.

#### SAFEGUARDING STUDENTS WHO ARE VULNERABLE TO EXTREMISM AND RADICALISATION

Our school recognises the duties placed on us by the Counter Terrorism Bill (July 2015) to prevent our students being drawn into terrorism.

These include:

- Assessing the risk of students being drawn into terrorism (see Appendix 5)
- Working in partnership with relevant agencies under the Safeguarding Children Partnership procedures
- Appropriate staff training
- Appropriate online filtering

Our school is committed to actively promoting the fundamental British values of democracy, the rule of law, individual liberty and mutual respect and tolerance of those with different faiths and beliefs; students are encouraged to develop and demonstrate skills and attitudes that will allow them to participate fully in and contribute positively to life in modern Britain.

There is a current threat from terrorism in the UK and this can include the exploitation of vulnerable young people, aiming to involve them in terrorism or to be active in supporting terrorism.

Our school seeks to protect children and young people against the messages of all violent extremism including but not restricted to those linked to-Islamist Ideology, Far Right / Neo Nazi / White Supremacist ideology etc. Concerns should be referred to the Single Point of Contact (SPOC) (usually a Designated Safeguarding Lead or Headteacher) who have local contact details for Prevent and Channel referrals. They will also consider whether circumstances require Police to be contacted.

#### **APPENDIX 6**

#### FEMALE GENITAL MUTILATION

Section 5B of the Female Genital Mutilation Act 2003 and section 74 of the Serious Crime Act 2015 places a mandatory duty on teachers along with social workers and healthcare professionals to report to the police where they discover that FGM appears to have been carried out on a girl under 18 or where a girl discloses that she has undergone FGM. The school's response to FGM will take into account the government guidance, "Multi-agency statutory guidance on female genital mutilation" April 2016. Staff will also follow the established safeguarding procedure by reporting any such concerns to the Designated Safeguarding Lead and a report must also be made to the Police.

There will be a considered safeguarding response towards any girl who is identified as being at risk of FGM (e.g. there is a known history of practising FGM in her family, community or country of origin) which may include sensitive conversations with the girl and her family, sharing information with professionals from other agencies and/or making a referral to Children's Social Care. If the risk of harm is imminent there are a number of emergency measures that can be taken including police protection, an FGM protection order and an Emergency Protection Order.

#### APPENDIX 7 Indicators of abuse and neglect

Abuse, neglect and safeguarding issues are rarely standalone events that can be covered by one definition or label. In most cases, multiple issues will overlap with one another.

**Physical abuse:** a form of abuse which may involve hitting, shaking, throwing, poisoning, burning or scalding, drowning, suffocating or otherwise causing physical harm to a child. Physical harm may also be caused when a parent or carer fabricates the symptoms of, or deliberately induces, illness in a child.

Emotional abuse: the persistent emotional maltreatment of a child such as to cause severe and adverse effects on the child's emotional development. It may involve conveying to a child that they are worthless or unloved, inadequate, or valued only insofar as they meet the needs of another person. It may include not giving the child opportunities to express their views, deliberately silencing them or 'making fun' of what they say or how they communicate. It may feature age or developmentally inappropriate expectations being imposed on children. These may include interactions that are beyond a child's developmental capability as well as overprotection and limitation of exploration and learning or preventing the child from participating in normal social interaction. It may involve seeing or hearing the ill-treatment of another. It may involve serious bullying (including cyberbullying), causing children frequently to feel frightened or in danger, or the exploitation or corruption of children. Some level of emotional abuse is involved in all types of maltreatment of a child, although it may occur alone.

**Sexual abuse:** involves forcing or enticing a child or young person to take part in sexual activities, not necessarily involving a high level of violence, whether or not the child is aware of what is happening. The activities may involve physical contact, including assault by penetration (for example rape or oral sex) or non-penetrative acts such as masturbation, kissing, rubbing and touching outside of clothing. They may also include non-contact activities, such as involving children in looking at, or in the production of, sexual images, watching sexual activities, encouraging children to behave in sexually inappropriate ways, or grooming a child in preparation for abuse. Sexual abuse can take place online, and technology can be used to facilitate offline abuse. Sexual abuse is not solely perpetrated by adult males. Women can also commit acts of sexual abuse, as can other children. The sexual abuse of children by other children is a specific safeguarding issue in education.

**Neglect:** the persistent failure to meet a child's basic physical and/or psychological needs, likely to result in the serious impairment of the child's health or development. Neglect may occur during pregnancy, for example, as a result of maternal substance abuse. Once a child is born, neglect may involve a parent or carer failing to: provide adequate food, clothing and shelter (including exclusion from home or abandonment); protect a child from physical and emotional harm or danger; ensure adequate supervision (including the use of inadequate care-givers); or ensure access to appropriate medical care or treatment. It may also include neglect of, or unresponsiveness to, a child's basic emotional needs.

#### APPENDIX 8 Covid - 19 Response

March 2020: Addendum to Safeguarding Policy

# 1. Vulnerable Students

Woodbrook Vale School has identified students who are considered to be vulnerable. Some, but not all, of these students fit into the DfE categories of students with a social worker and/or a Child Protection Plan and students with an EHCP. Students who fit into the DfE criteria for vulnerable children have all been offered provision at Woodbrook Vale School.

In addition to these students DSL's have identified as vulnerable students who are:

- educated off site through the Loughborough Inclusion Partnership;
- some SEND (K) students;
- students with involvement from the Children and Families Wellbeing Service and students with SEMH difficulties receiving greater levels of pastoral support at Woodbrook Vale and / or from external agencies.

All students who have been identified have been added to a vulnerable student register and have been allocated a key member of staff.

All the identified students will receive at least weekly telephone calls from the identified member of staff. Where there are concerns raised these will be followed up with the senior DSL and appropriate action will be taken. This may include signposting to healthcare professionals, Early Help or, if appropriate, First Response.

All calls and actions are centrally recorded and monitored by the senior DSL on a daily basis. Where necessary more regular contact will be made and / or existing professional involved outside of school notified.

Children's social care are not currently recommending home visits to vulnerable students. However, if this is necessary two members of staff from Woodbrook Vale would conduct a doorstep visit jointly.

# Students educated through the Loughborough Inclusion Partnership

- These students have an identified LIP key worker based on continuity.
- LIP key workers have a contact record that is shared weekly with Woodbrook Vale School.
- The senior DSL is the key contact for safeguarding concerns relating to LIP students.

# 2. Procedures for students on campus.

- All students wash hands on arrival and before and after break and lunch and before leaving the building.
- Students and staff expected to stay at 2m distance.
- No hand ball or object passing games.
- Students will complete work that has been set on Go 4 Schools, Google Classroom and occasionally supplemented with other activities.
- A DSL is on site at all times. All concerns will be logged on CPOMs during partial closure as normal.
- A First Aid trained person is on site or within 5 minutes of site at all times.
- All equipment must be wiped down after use.
- Children and staff MUST stick to the timetabled classrooms to ensure cleaning rotas are maximised.

# 3. Setting work and communicating with students from home

- Staff will set work on Go 4 Schools and place documents for student use in either Go 4 Schools, Google Drive, Google Classrooms.
- All links to websites endorsed by the school will be placed on the school website. Teachers will not direct students to places on the internet that are not listed on the main Homework pages of the school website as trusted sites.
- Staff will not speak directly to students from home either by phone or email but go through parents/carers except when in protected spaces such as Google Classroom.
- Communications with children should usually run through the main office at school or a member of SLT.

# 4. Regarding receipt of students from other settings

In the event of cluster working where Woodbrook Vale may be asked to accept a child from another school, the following will be put in place:

- The student/s must be accompanied by a member of staff from their own establishment who knows them.
- Students emergency contact details and any medical conditions must be supplied on entry to the building.
- Procedures for hygiene and safety, including Fire Arrangements must by notified on arrival. Visiting students must not be left unsupervised at any time.

# 5. Sending WBV students to other settings

In the event of cluster working where Woodbrook Vale may be asked to send a child to another school, the following will be put in place:

- The student/s must be accompanied by a member of staff from Woodbrook Vale who knows them.
- Students emergency contact details and any medical conditions must be supplied on entry to the building.
- Procedures for hygiene and safety, including Fire Arrangements must be notified on arrival. Visiting students must not be left unsupervised at any time.

# 6. Free School Meals

During school closure due to Coronavirus, children entitled to Free School Meals will have provision using the government voucher scheme once it is launched.

Where parents are struggling – Woodbrook Vale is able to issue vouchers to local Foodbanks to ensure children do not go hungry.
